

## COVID-19 RELEASE

I, the undersigned, legal parent or guardian of the below listed campers, acknowledge the contagious nature of the COVID-19 virus, and respect that Camp Alexander adheres to the CDC recommendations of practicing social distancing and wearing face coverings.

I further acknowledge that Camp Alexander has put in place preventative measures to reduce the spread of the COVID-19 virus to the best of its ability. However, I further acknowledge that by the very nature of camping and managing youths, the campers will come in contact with each other in ways that could transmit COVID-19. As such, no guarantee exists regarding whether myself or my camper(s) may contract COVID-19. I understand that even with protocols in place, the risk of becoming exposed to and/or infected by the COVID-19 virus may result from the mere nature of summer camp and also from the actions, omissions, or negligence of myself or my camper(s) and others, including, but not limited to, staff and other campers and their parents/guardians.

I acknowledge that the risk of exposure to COVID-19 is increased to myself and my camper(s) by participating in summer camp at Camp Alexander.

I acknowledge that I and my camper(s) must comply with all set procedures to reduce the spread while in attendance.

I attest that:

- My camper(s) is/are not experiencing any symptoms of illness such as cough, shortness of breath, difficulty breathing, fever, chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- My camper(s) has/have not traveled internationally within the last 14 days.
- My camper(s) has/have not traveled to a highly impacted area within the United States in the last 14 days.
- I do not believe my camper(s) has/have been exposed to someone with a suspected and/or confirmed case of COVID-19.
- My camper(s) has/have not been diagnosed with Coronavirus/COVID-19 by state or local public health authorities.

- My camper(s) is/are following all CDC recommended guidelines as much as possible, including limiting any purposeful exposure to COVID-19.
- My camper(s) has/have not been advised to self-quarantine by a medical professional.

I hereby release and agree to hold Camp Alexander harmless from any causes of action, claims, demands, damages, costs, expenses and compensation for damage to myself or my camper(s) that may be caused by any act, or failure to act, or that may otherwise arise in any way with my camper(s) participation at Camp Alexander. I understand that this release discharges the aforementioned from any liability with respect to bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received. This liability waiver and release extends to Camp Alexander's Board of Directors and its employees.

Finally, although Camp Alexander is monitoring both the availability of COVID-19 vaccines and evolving potential legal requirements, Camp Alexander does NOT require that campers, parents/guardians or staff entering the camp or coming into contact with other campers, parents/guardians or staff be vaccinated. By signing this waiver, you acknowledge that you have no right to expect other campers, parents or staff be vaccinated.
